Going forward all Director positions are elected or appointed for two-year terms. Directors must be permanent and active PSAANS members.

PSAANS Board of Directors Executive

The executive consists of four positions; Chair, Vice-Chair, Secretary and Treasurer. Executive positions are chosen by the board following the Board of Directors ratification at the AGM in October.
